# • Roll Call:

# • Approve January Meeting Minutes:

- o Discussion on the minutes to make sure everyone received them.
- A motion was made to approve the January Meeting minutes and was seconded. Minutes approved

**BOARD TO VOTE ON MARCH 7th** 

### 2017 By Law revision - Article 9 - RULES AND PROVISIONS

# Proposed new wording:

#### **SECTION A. Men's Club members:**

1. Member's must have five (5) attested rounds of play at Majestic Oaks each golfing season. The failure to have required rounds may result in non-renewal of membership the following year. It is the member's responsibility to ensure that all attested rounds are duly recorded on the handicap listing, which is the official source to resolve any disputes. Any member disqualified under this rule will be notified in writing by March 15 of each year. Any disqualified member has the option to present any extenuating circumstances to the Board of Directors, in person, at any regularly scheduled board meeting to request reinstatement.

In order to participate in the Club Championship and/or the Senior Club Championship each member must have participated in one (1) of the following scenarios:

- A. Two (2) 18-hole major events. (Two-day events count as one event).
- B. One (1) 18-hole major event and Four (4) 9-hole Tuesday or Wednesday league events.
- C. Eight (8) 9-hole Tuesday or Wednesday league events.

Note: If you are a past Club Champion or Senior Club Champion and are a current member in good standing you are automatically eligible to participate in the event you previously one.

#### Here is the wording as of today:

1. Must have five (5) attested rounds of play at Majestic Oaks each golfing season, two (2) of which must be a Men's Club 18 hole event to be eligible for either the Senior Club Championship, and/or the Club Championship.

A member has the option of two (2) 18 hole events or Four (4) Men's Club Tuesday night 9 hole events which equals one (1) Men's Club 18 hole event and eight (8) Men' Club Tuesday night 9 hole events which equals two (2) Men's Club 18 hole events. However if you are a past Club Champion or Senior Club Champion and a current member in good standing you are automatically eligible to participate in the event you previously won. In addition, the failure to have required rounds may result in non-renewal of membership the following year. It is the member's responsibility to ensure that all attested rounds are duly recorded on the handicap listing, which is the official source to resolve any disputes. Any member disqualified under this rule will be notified in writing by March 15 of each year. Any disqualified member has the option to present any extenuating circumstances to the Board of Directors, in person, at any regularly scheduled board meeting to request reinstatement.
